There are lots of great initiatives going on around the sector – for example Chester have one around growing vegetables called Garden to Table. Matt suggested that we meet regularly as a group and one person will serve as 'Editor-in-Chief'. He feels that each story should have a podcast to itself and this would be pre-recorded. Ian would be in favour of having a bank of these so that we do not run out. The member would film themselves talking about the project, along with some visuals, then TUCO would put the final bit together. The podcast would then be removed after a period of time.

Mike feels that this should take the form of a webinar and would prefer to have a single person talking about the initiative. Dave agrees that we do need some visuals on this. Matt stated that he would be open to more people joining the group and lan suggested that this is something that we can push with the Regional Chairs. The agreed time length for the podcast would be approximately 10 minutes – 5 to 10 minutes of discussion and a few minutes of the visuals.
