1. Welcome and Apologies

Apologies as listed above. Emma welcomed everyone to the meeting.

2. Minutes of the Last Meeting

These were taken as agreed.



3. Academy Update (Sarah)

From April 2022 to March 2023 we delivered courses to 510 delegates which was up 100 on the year before. In April and May 2023 we have already delivered 23 courses with 223 attendees. We have been able to increase the number of courses on offer by having back Camilla Hayes, who has been delivering in-person training in Leicester, Nottingham and Leeds.

Development Days:

• Visual Merchandising Safari in London and Manchester – the delegates will be given the theory on marketing and some background in customer service and then will be taken on a tour to see how this works in the private sector.

StudyTours:

We recently held a Food To Go study tour to Paris in conjunction with Simply Lunch for 22 people. We will run this again in the future, possibly in Dublin or Germany.

- **Liverpool Study Tour** taking in the four universities Liverpool John Moores, Edge Hill, Liverpool Hope and the University of Liverpool and looking at the African/Asian culture there, ending in a visit to an African themed food festival.
- CIA Conference this is available online now with two bursary places to New York State
- Studentenwerke Conference 5th to 7th July in Neustadt near Mannheim which will include a food safari around Frankfurt. Delegates from Korea and Japan will be attending this.
- LWC Italy pairing beer and wine with food and visiting a vineyard TBC.
- Colombia 2024 a Caffeology Study Tour details yet to be announced but this will probably be May 2024.
- Bologna Barista For £495 this will involve a full week of interactive training from w/c 19th February 2024 in conjunction with Bewleys. This includes SCA Accreditations and will be useful for when Competitions start up again.

Our Winter Conference 2023 will be held on Wednesday 6th December at the University of Kent with a social dinner the previous evening. The theme will be the Cost of Living Crisis. James Payne (who presented in an earlier webinar this year on the Food Market update (inc potential price changes) will be one of the speakers and Charles Banks will be presenting on Global Food Trends. We also have The Food Foundation presenting with Kent University on their Right to Food Initiative which looks at healthy, affordable and sustainable food for all.

4. TUCO Board Update (Mike Haslin)

We are looking to resurrect the Competitions in April 2024. We have had the initial exploratory meeting for this and will re-run the Chefs' Challenge. We are also in the process of creating the Chefs' Forum and will be meeting for the first time at the St Andrews Conference. The Conference currently has 90 exhibitors and 150 people booked on so far, which is massively up on last year. The speaker programme is looking good.

We have had 14 new Associate members including NHS Trusts, LEAs and academies. Spend for the first quarter is the highest we have ever recorded, which is a clear signal that business is returning to normal. We are also looking to create a TUCO Foundation, which will tick the boxes for a Charity.



5. Procurement Update (Jane)

Jane reported that there is a gap in the quantity of Fruit & Veg as produce from the UK has been slow coming through because of the weather. Sarah Jones has now joined us from the University of Manchester and will be the focal point for mini-competitions as well as supporting us on the MSC.

The UKUPC Impact document has now been issued.

Tender Renewals

Grocery, Frozen and Chilled new framework is in place. We have added Vegan and Vegetarian as a separate lot to this agreement. Catering Light and Heavy – we are hoping to start this on $1^{\rm st}$ July. Kitchen Equipment Maintenance – new agreement started on $1^{\rm st}$ June but not as a DPS this time. DipChem – Natalie will be starting work on this shortly. EPOS has two new suppliers on there, including 'It's Lolly'. On the Hot Beverage framework, volunteers for the Tender Working Party are needed.

Price Changes

Work is commencing on the Convenience Retail re-tender. New prices are due in July. DipChem – there have been some price increases on various lines. Meat and Poultry – some price reviews as from 1st June. Milk and Bread – prices showing signs of stabilising. At recent Contract Review meetings, suppliers were asked to move back to six-monthly price reviews.

Jane asked members if they used the New Product Development page of the TUCO website as it appeared quite a few of our members did not know about this, which allows you to choose free samples of new products then give feedback on them.

6. Sustainability

Menus of Change are adopting a fresh approach using the 24 principles. A strategy document is being produced and an Excel spreadsheet to show what is in the 24 principles. NetPositive are also becoming involved in this. An MSC Accreditation audit is being arranged.

The TUCO Online User Group last met at the end of April and a new ordering portal on there is currently being trialled with Nottingham. We have been looking at digital menus and our consultant Jonny Stevens is leading on this in conjunction with Ten Kites.

7. Presentation by Adam Bostock from CCEP

A copy of this presentation is included with the Minutes.

8. NWUPC Update

The annual NWUPC Conference was held at the University of Manchester on Wednesday 14th June and focused mainly on Procurement Regulations. It also included a presentation by Sheri-Leigh Miles of NetPositive Futures on the Circular Economy.

9. Member Updates

Edge Hill

Paul reported that they are undergoing a major refurb. They are also recruiting for a Conference Manager and Hospitality Manager.



Manchester

Manchester have been the victim of a major cyber incident which has caused massive disruption. Kinetics has been down for around 10 days.

Liverpool Hope

They are now very busy with conferencing along with Project 24 with the new V-C for next year. Gary advised that they recently won a hospitality award at the recent U-Dine event. *Liverpool*

They have undergone a major re-structure. Chris Murphy has only just joined them from Chester. Mandy Johnston has taken responsibility for Catering and Ann will be Acting Head of Procurement until the new person starts.

Bolton

Derek reported that Bolton are having a big event on the following day (22nd June) and getting ready for Graduation at the Town Hall, which will run over 4 days.

10. Any Other Business

NetPositive's new interface has now gone live. Suppliers are being contacted to update their details.

11. Dates for Next Meeting

This will be held around mid-October time (exact date TBC) and it is hoped to hold this at a member institution.

About TUCO's framework agreements

We currently use 3 types of procedure under Public Contracts Regulations 2015

Restricted

The 2 stage, restricted procedure permits TUCO to "pre-qualify" suppliers based on their financial standing and technical or professional capability so as to narrow the number permitted to submit bids at the ITT stage (i.e. stage 2).

Open In an open procedure, anyone may submit a full tender as there is no "pre-qualification" of bidders.

DPS

There are two stages to this procedure; similar to the more commonly used restricted procedure, stage one is the pre-qualification stage and stage two is the award stage. TUCO have already carried out stage one in order to create a pre-qualified list of suppliers however approved users (i.e. Buyers / TUCO Members) MUST complete Stage 2. Approved users (buyers, TUCO members) award individual local contracts through the DPS. The buyer (TUCO member) invites all potential suppliers on the DPS (authorised supplier list) or within a particular lot to participate in a further competition bid for a specific contract. Suppliers must have a minimum of 10 days to submit their tender. Suppliers are not obliged to bid. All stage 2 document templates have already been created and are available for members to download and tailor to their individual requirements before issuing to the DPS suppliers. A contract award notice must be placed within 30 days of award by the TUCO member.
